ENHANCED WIRELESS 9-1-1 SYSTEM PAYMENTS TO COUNTY TREASURY, 2018-2022

By the last day of each month, the Tax Commissioner must disburse funds from the Wireless 9-1-1 Government Assistance Fund to each county treasury in the same proportion distributed to the county as it received in the same month of the previous year. The county treasurer then distributes the amount received via an allocation formula to other subdivisions within the county and regional councils of governments in the county that operate an answering-point for enhanced wireless 9-1-1 calls.

Prior to the October 2021 payment, the disbursements were based on the 2013 payments from the Public Utilities Commission of Ohio (PUCO). This essentially had the effect of freezing the amount that county treasuries received from 2013 to 2020. Under a provision in House Bill 110, the main operating budget of the 134th General Assembly, the reference was changed to the aforementioned proportion to the prior calendar year. This change has not altered the proportion of the total distribution each county receives but has allowed the total size of the distribution to increase.

This provision can be found in <u>ORC 128.55</u>.
