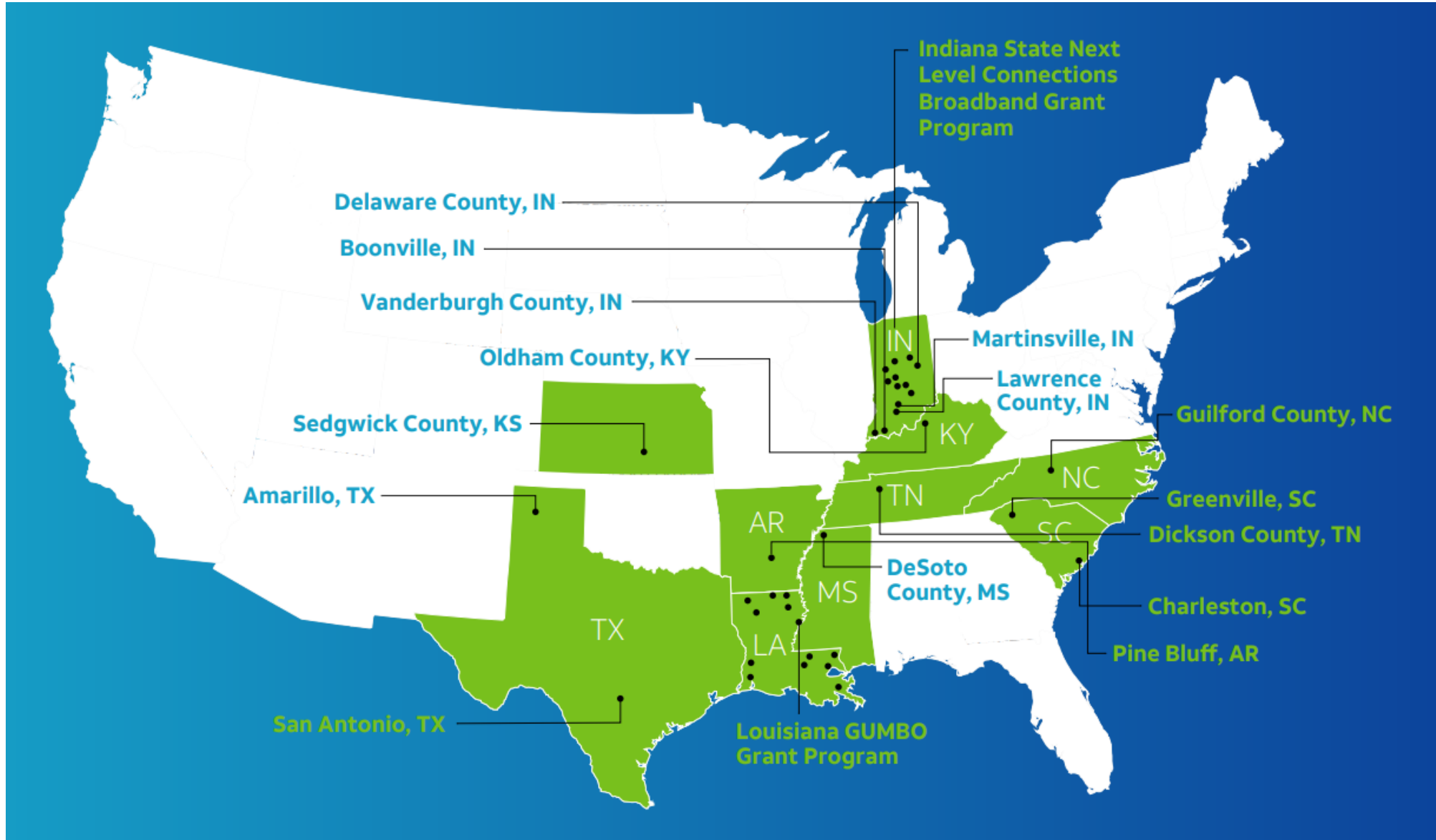
# Biden-Harris Administration Announces \$793.7 Million to Ohio for High-Speed Internet Infrastructure

**WASHINGTON** – The Department of Commerce’s National Telecommunications and Information Administration (NTIA) today announced that Ohio will receive \$793,688,107.63 to deploy affordable, reliable high-speed Internet service. Right now, 183,709 homes and small businesses in Ohio lack access to a high-speed Internet connection.
