

WHY WE'RE HERE

- More than nine out of 10 beds at our state psychiatric hospitals are occupied by forensic patients, challenging our ability to keep pace with court referrals for forensic admissions.
- This limits our state psychiatric hospitals' ability to serve citizens with serious mental illness who are not criminal justice involved.






- Forensic population has grown over time squeezing out access and capacity of civil beds in the state hospitals.
- Rise in competency restoration referrals from both municipal and common pleas courts.
- Ohio's criminal justice systems are often using competency restoration as a pathway to access mental healthcare rather than for it's intended purpose.
- Bed days are overutilized for a complicated legal process shutting out access for dedicated mental health care

COST PER PATIENT

- The number of patients served has ٠ decreased.
- The total expenditures have ٠ steadily increased.

Governor DeWine Convenes New Work Group on Competency Restoration and Diversion

April 03, 2024

(COLUMBUS, Ohio)—Ohio Governor Mike DeWine today convened a new working group to address the increasing number of criminal justice-involved (forensic) patients being treated at Ohio's six regional psychiatric hospitals.

Ohio's six state-run regional psychiatric hospitals exist as a safety net for Ohioans experiencing serious mental illness and provide comprehensive in-patient care and treatment to more than 1,000 patients daily. These specialized facilities provide services for civil patients as well as those referred by criminal courts. Over time, the forensic population has steadily increased, squeezing out access and capacity of civil beds in the state hospitals. Forensic patients – which include jail transfers, restoration to competency and Not Guilty by Reason of Insanity patients – currently account for





WORKGROUP GOALS

- Ensure adequate access to state psychiatric hospital beds for those experiencing a crisis and are not criminal justice involved.
- Develop recommendations to enhance Ohio's outpatient competency restoration program.
- Develop best practices and strategies for expanding jail diversion programs for those with mental health and substance use disorders.
- Develop strategies to expand access to jail-based competency restoration and treatment.
