# Thrust into the Spotlight: Crisis Communication Lessons from a County Leader

After the September debate in which then-presidential candidate Donald Trump said the Haitian refugees in Springfield, Ohio were "eating the cats and dogs," the small community of 60,000 became headline news for weeks. Not only did the media swarm the city, but bomb threats and protests followed from nationalists, hate groups and attention-seekers looking for their 15 minutes of fame.

Clark County Commissioner Melanie Wilt, a 25-year veteran of the PR profession, found herself in the unwitting position to protect her county seat's image from claims that it had been wholly ruined by legal immigrants. Meanwhile, the community was financially stressed and divided by a sudden culture clash that started over a year before when a Haitian driver caused a bus to crash killing an 11-year-old boy.

Melanie will draw on her experience as a leader and PR professional to dig deeper into what you can do to plan, prepare and practice for your time in the spotlight. After all, when it comes to crisis, it's not a matter of "if" but "when."
