CCAO SERVICE CORPORATION PROGRAM NEWS

CCAO - ENDORSED SERVICE PROGRAMS/WINTER CONFERENCE TRADE SHOW RECAP

As you may have noticed, if you were able to attend

the CCAO/CEAO Winter Conference trade show this week, many CCAO-endorsed vendors were present at the show to talk about their respective goods and services. Several prominent examples of these vendors being the newly-endorsed Cost Control Associates and GovDeals.com. GovDeals.com offers online auction services of surplus materials and confiscated personal property. Cost Control Associates offers energy and telecommunications utility billing analysis.

Several consistently-endorsed companies such as Colonial Supplemental Insurance were present as well. Colonial administrates our Flexible Benefits Program. It enables counties to offer employees the opportunity to pre-tax qualified employee benefit premiums that they contribute to health, dental, and life insurance. Flexible benefits are authorized under IRS Section 125. The law also authorizes the same pre-tax advantages for other qualified medical and dependent care expenses.

The local arm of MAXIMUS, which operates out of the Cleveland area, was also present at the show. MAXIMUS currently provides cost plan services for 81 Ohio counties. OMB Circular A-87 cost plans identify indirect costs in strict accordance with federal accounting standards, and are used as the basis for securing reimbursements for federal and grant contract sources. Full cost plans are also used to claim reimbursement from enterprise funds and fee-supported fund activities. Cost recoveries reduce or eliminate the need for general tax subsidies of these activities.

Securus Technologies was also present, and represents one of the County Commissioners Association of Ohio's older Enterprise Service Programs. We are pleased to re-iterate our endorsement of their pay phone commission program and other related telecommunications services for county jail facility use.

Great West Retirement Services was located in the hallway of the main conference floor, and had representatives available to help anyone interested in Section 457 retirement questions. The CCAO Deferred Compensation Program was established in

1985 to serve the needs of county employees. Approximately 24,000 county officials and employees in 88 counties defer additional money to supplement their retirement under the program. Great West administrates this program in conjunction with a committee of county officials who recognize the needs of their employees.

These programs have been created to save Ohio county governments and their respective departments money and administrative costs. STATE ACTIVITIES

OHIO EPA RECEIVES U.S. EPA APPROVAL FOR OHIO'S WATER QUALITY MANAGEMENT PLAN

With the approval of Ohio's statewide water quality plan by the federal EPA, Ohio EPA will now review applications for central sewer systems in western Franklin County using the criteria established in the plan. In cooperation with local communities, this will help protect water quality in the Big Darby Creek watershed. The previous plan had put a hold on installing sewers within the Big Darby watershed portion of Franklin County.

Section 208 of the federal Clean Water Act requires states to identify regional water planning areas to prepare, maintain and implement water quality management plans. Five regional governments councils updated their plans within the last year and Ohio EPA updated plan content covering 42 additional counties. Governor Taft certified the plan updates on September 1, 2006.

These plans contain information used to address both municipal wastewater treatment issues and nonpoint source pollution management and control. Information from the regional plans are combined to form a statewide water quality management plan.

Ohio EPA efforts to maintain or improve the water quality of the Big Darby Creek watershed will include:

- minimizing storm water runoff by including performance standards in Ohio EPA storm water permits issued for construction sites in the watershed;
- requiring green space or a setback distance to be left between new development sites and streams in the watershed to keep sediment and other pollutants out of the water;
- sustaining water supply through ground water recharge requirements;
- reviewing new and renewal permits for sources that discharge from a pipe to ensure compliance with discharge limits;
- reviewing applications to Ohio EPA for dredging projects or placement of fill in the watershed with an eye toward meeting water quality objectives;
- encouraging agricultural practices that reduce phosphorus and sediment runoff to streams in the watershed; and
- reducing pollution from home sewage systems, particularly phosphorus and pathogens.

Two public meetings and a comment period were held while the plan was in draft form. DHS ANNOUNCES APPLICATION PERIOD FOR FY06 FIRE PREVENTION AND SAFETY GRANTS

The Department of Homeland Security (DHS) announced last week the application period and posted the guidance document for the *Assistance to Firefighters Grant Program* and *Fire Prevention and Safety Grants* (FP&S). The FP&S grants support

projects that enhance the safety of the public and firefighters from fire and related hazards.

The application period began Monday, December 4. The DHS Office of Grants and Training will accept applications for the FP&S grants until 5 p.m., January 12, 2007.

The FP&S grant guidance is available at www.firegrantsupport.com/docs/2006FPSguidance.pdf. The guidance document is designed to help users prepare and submit competitive applications and provide an overview of the programs funding priorities and evaluation criteria.

FEDERAL ACTIVITIES

SBA DISASTER LOANS AVAILABLE FOLLOWING OHIO'S AGRICULTURAL FLOOD DAMAGE

The U.S. Small Business Administration (SBA) announced on November 30 that federal disaster loans are available to small, non-farm businesses located in the Ohio counties of Ashtabula, Geauga, Hancock, Lake, Lorain, Medina, Muskingum, Ottawa, Wood and Wyandot as a result of damages and losses to crops caused by excessive rain and flooding that occurred May 10 and continuing. The contiguous counties of Allen, Ashland, Coshocton, Crawford, Cuyahoga, Erie, Guernsey, Hardin, Henry, Huron, Licking, Lucas, Marion, Morgan, Noble, Perry, Portage, Putnam, Sandusky, Seneca, Summit, Trumbull and Wayne are also eligible for disaster loans.

Under this declaration, SBA's Economic Injury Disaster Loan (EIDL) program is available to farm-related and non-farm-related small business concerns and small agricultural cooperatives that suffered economic injury as a direct result of this disaster. Farmers and ranchers are not eligible to apply to SBA.

Eligible small businesses may qualify for loans up to \$1.5 million. These loans are available at a four percent interest rate with loan terms up to 30 years. SBA determines eligibility for the program based on the size and type of business and its financial resources. Loan amounts and terms are set by SBA and are based upon each applicant's financial condition. Under this disaster declaration, SBA cannot provide loans to agricultural producers.

2007 ACTS OF CARING AWARD - DEADLINE JANUARY 17

In 2007, the National Association of Counties (NACo) will recognize and promote volunteer programs through the Acts of Caring Awards, a national ceremony honoring community-based, county government initiatives that provide a legacy for the future of our country. The Acts of Caring is part of County Serve America, a long-term project of NACo that is designed to raise public understanding and awareness about county government.

An "act of caring" is a community service provided by a county-sponsored volunteer program that enhances or preserves the quality of life. Any county government that is a member of NACo with an active program that meets the application criteria is eligible to participate in the Acts of Caring awards.

Up to 18 programs will be recognized and deemed examples of outstanding Acts of Caring. Based on county size, as many as three programs will be recognized in each of six categories, including:

community improvement, criminal justice/emergency management, elderly services, health/social services, libraries and programs for children and youth. In addition, one Youth Service Award and one Legacy Award for Excellence and Innovation will be given. This year's competition will feature cash awards for the Youth Service Award (\$1,000) and the Legacy Award for Excellence and Innovation (\$1,500).

Ohio has a successful history of winning an Acts of Caring award. Past winners from Ohio include: Hamilton, Portage (3), Summit (2), Erie, and Lucas. Three years ago, Portage County won the highly coveted Legacy Award.

BOARD OF DIRECTORS ADOPTS 2007 BUDGET & LEGISLATIVE PRIORITIES

The NACo Board of Directors recently adopted the 2007 budget and legislative priorities at their meeting held in Franklin County recently.

The NACo Board adopted the Finance Committee's recommendation of an \$18.7 million budget for 2007 with an expected budget surplus of \$1.6 million.

In addition the following 2007 legislative priorities were adopted:

- Reauthorization of the Farm Bill;
- Repeal of the withholding tax law and reform of other federal tax changes (such as telecommunications taxes) affecting counties;
- Reforms of health and human services laws and policies, particularly reducing the county share of Medicaid and restoring cuts imposed by the Deficit Reduction Act to child support, child welfare and the Temporary Assistance for Needy Families Block Grant program;
- Reauthorization of the Secure Rural Schools and Community Self Determination Act and enhanced appropriations for the Payment in Lieu of Taxes (PILT) program;
- Reauthorization of the federal Airport and Aviation program;
- Assistance to counties to combat methamphetamine abuse; and
- Opposition to unfunded mandates and preemptions.

A special note on legislative priorities: NACo's Large Urban County Caucus and Rural Action Caucus have priorities that are consistent with the key legislative

priorities listed above and will be advocating these priorities on behalf of urban and rural counties.

2007 FIVE STAR WETLAND, COASTAL HABITAT RESTORATION PROJECT AWARDS

The National Association of Counties (NACo) and the Five Star Restoration Challenge Grant Program project partners are accepting applications for the 2007 Five Star Restoration Grants. Modest financial assistance on a competitive basis is available for community-based wetland, riparian and coastal habitat restoration projects that build diverse partnerships and foster local natural resource stewardship through education, outreach and training activities. Project sites can be public land, such as parks, streams, and school campuses, or private land, such as corporate facilities.

In 2006, 39 projects out of approximately 126 applications received grants averaging including the following Ohio counties:

- Cuyahoga County (Cleveland) - \$10,000 grant for the Puritas Wetland Collaborative and
- Franklin County (Worthington) - \$10,000 grant for the Rush Run Riparian Restoration Project.

Begun in 1997, The Five Star Restoration Challenge Grant Program is a partnership between NACo, the National Fish and Wildlife Foundation, the Wildlife Habitat Council, in cooperation with the U.S. Environmental Protection Agency and the newest partner Southern Company. Applications must be postmarked by March 9, 2007.

NPELRA ACADEMY II: THE ARBITRATION PROCESS

The National Public Employer Labor Relations Association (NPELRA) will hold “Academy II: The Arbitration Process” on February 7, 2007 at Cherry Valley Lodge, 2299 Cherry Valley Road, in Licking County (Newark).

Academy II presents a thorough grounding in the role of arbitration in union-management relations from the perspectives of the practitioner, the arbitrator, and the advocate. Workshops cover tips for responding to grievances, the rules of contract construction and how and when to raise arbitrability. Participants will draft a response to a grievance and learn how to improve their skills in preparing and presenting a winning case. An arbitrator will discuss what works and what doesn't and present the key elements of the burden of proof. A cross-examination demonstration using dramatic examples and a review of preparing for interest arbitration complete the session.
