OPINION SURVEY ON HIGHER EDUCATION; THE STATE OF OHIO WOULD LIKE YOUR FEEDBACK

The Ohio Board of Regents Chancellor Eric Fingerhut needs your input as he begins work on a 10-year plan to develop a world - class system of higher education in Ohio. The Legislature and Governor Ted Strickland have charged the Chancellor with building a system designed to prepare all Ohioans for the 21st century and rival the nation in accountability and innovation.

The survey takes less than five minutes and is posted at www.universitysystem.ohio.gov/survey for your convenience. It contains questions asking for your views on college affordability, research, funding, accessibility, student success, opportunities, barriers and more. Survey deadline: December 31, 2007.

The plan is due to the Ohio General Assembly by March 31, 2008. It will contain goals, benchmarks and strategies for building our world class system. Your thoughts and opinions on the needs and strengths of higher education in Ohio will certainly help the Chancellor formulate the plan and move it forward.

PROPOSED OAC AMENDMENTS ADDRESSING WATER QUALITY STANDARDS

The Ohio EPA has announced proposed amendments addressing water quality standard rules in Ohio Administrative Code (OAC) Chapter 3745-1. Rules to be amended include the following river drainage basins: Hocking, Scioto, Grand, Rock River, Great Miami, Chagrin, Portage, Muskingum, Mahoning, and Black Rivers.

The Ohio EPA Division of Surface Water conducts water quality and biological surveys of Ohio's rivers and streams. One outcome of this work is an assessment of the beneficial uses assigned to specific water bodies in the State's water quality standards rules. The Clean Water Act (CWA) requires all states to conduct such assessments and to designate waters for beneficial uses that support the CWA "fishable and swimmable" goals wherever attainable. All waters are presumed to be capable of supporting goals uses unless the state provides a use attainability analysis (UAA) explaining the reasons why the goals of protecting aquatic life and recreation cannot be attained in the water.

A public hearing is scheduled at 2:00 p.m. on December 11, 2007 at the Ohio EPA Central Office, 50 West Town Street - Suite 700, Room C, in Columbus. ATTORNEY GENERAL'S OPINION

No. 2007-038. SYLLABUS:

Requested by Morrow County Prosecuting Attorney Charles S. Howland.

A county zoning resolution may not be amended to prohibit the installation and operation of landfills that are licensed as construction and demolition debris facilities or solid waste facilities under R.C. 3714.06(A) or R.C. 3734.05(A), respectively, throughout the entire unincorporated territory of the county.

FEDERAL ACTIVITIES

PRESIDENT VETOES LABOR-HEALTH & HUMAN SERVICES-EDUCATION APPROPRIATIONS

The House and Senate had a quick conference on Labor/HHS and the House approved the conference agreement November 6, but it hit a bump when it got to the Senate. Under a new procedural rule adopted by the Senate earlier this year, the conference report was subject to a point of order because it included the Military Construction/Veterans Appropriations bill, which had not been part of either chamber's Labor/HHS bills. The Senate failed 13 votes short of the 60 votes needed to overturn the point of order. As a result, the Senate sent a stand alone Labor/HHS back to the House. The House approved the new bill November 8. The President vetoed the measure on November 14 because its spending levels are above his budget requests.

The Labor-HHS Conference agreement includes a \$245 million rescission for Workforce Investment Act (WIA) funding from Fiscal Year (FY) 2005 and 2006, but gives the Secretary of Labor the authority to take the funds out of unspent FY 2007 funds at the Governor's request. The House had included a \$335 million rescission while the Senate did not included one at all. This \$245 million rescission will likely come from those states with an excess of 30 percent in workforce carryover funds first. A cut may be applied across the board if the funding from those states with carryover funds is not sufficient. The conference agreement also provides level funding for WIA programs for FY 2008. TRANSPORTATION AND HOUSING APPROPRIATIONS READY FOR FINAL ACTION – VETO THREATENED

On Thursday, November 8, the House-Senate Conference Committee agreed to funding levels for the Department of Transportation and HUD for FY2008. This week, the conference report was accepted by the House and will move to the Senate.

The bill sets overall transportation and housing program spending above the Administration's budget request. As a result, a White House veto threat still hangs over the bill.

The conference report sets spending for the U.S.

Department of Housing & Urban Development (HUD) at \$38.66 billion, an amount \$3.1 billion over the Administration's budget request. The bill sets funding for CDBG at \$3.79 billion, a \$100 million dollar increase over FY 2007. The conferees firmly rejected the Administration's request to cut CDBG funding by \$1 billion. The report also includes \$10 million for brownfields redevelopment, level funding from last year; and approximately \$17 million for Rural Housing and Economic Development, also level funded from FY 2007. The bill includes \$200 million in funding for foreclosure mitigation assistance that will be distributed through the Neighborhood Reinvestment Corporation.

The bill includes full funding for the federal highway program at the \$40.2 billion level and an additional \$1 billion for the federal bridge program. Also increased was the transit program, funded at \$9.677 billion, which meets the guaranteed funding levels under SAFETEA-LU. The Airport Improvement Program (AIP) is funded at \$3.515 billion, which is the current level, and Essential Air Service receives \$110 million. Amtrak gets \$1.45 billion, \$156 million over 2007 and \$550 million over the President's request. HOUSE COMMITTEE APPROVES MORTGAGE FINANCE BILL

The Financial Services Committee of the U.S. House of Representatives approved legislation last week to overhaul regulations governing the nation's mortgage finance system. The Mortgage Reform and Anti-Predatory Lending Act (H.R. 3915), was approved by the committee on a 45-19 vote. Purposes of the Act include reforming consumer mortgage practices and providing accountability for such practices. establishing licensing and registration requirements for residential mortgage originators, and providing certain minimum standards for consumer mortgage loans. NACo and other local government groups signed onto a letter supporting provisions in the bill that would protect state and local authority to enact their own anti-predatory lending laws. Such language is opposed by industry groups fearing a patchwork of lending regulations across the country. Language in the bill also includes "safe harbor" protections for subprime lenders who meet certain underwriting standards. As of press time, H.R. 3915 was on the floor. HOUSE JUDICIARY COMMITTEE APPROVES THE REAUTHORIZATION OF THE MENTALLY ILL OFFENDER TREATMENT AND CRIME REDUCTION ACT

With strong bipartisan support, the House Judiciary Committee on November 7 approved reauthorization of the Mentally III Offender Treatment and Crime Reduction Act (MIOTCRA), H.R. 3992. The legislation raises the authorization level of MIOTCRA from \$50 million per year to \$75 million and extends the authorization for the program through 2013. The bill offers grants to local governments and states to develop diversion programs, training programs and after-care services. The legislation also reauthorizes the Mental Health Courts grant program. The bill is expected to be placed on the House Suspension Calendar later this month. The Senate companion bill, S.2304 is expected to be considered in the Senate before the Thanksgiving recess. (Contact: Donald Murray, NACo Senior Legislative Director. NACO RURAL HEALTH WORKS TECHNICAL ASSISTANCE GRANTS

The National Association of Counties (NACo) is now accepting applications for the Rural Health Works Technical Assistance Grant for rural counties. Rural Health Works is community assessment process that assists counties to evaluate their healthcare system and to generate county-specific data. The ultimate goal of the project is to strengthen rural economies by increasing the use and expansion of health services.

NACo will award a total of three grants on a competitive basis. The grant, valued at more than \$18,000 for each county, includes intensive technical assistance on the Rural Health Works model.
