CCAO/CEAO/OSU EXTENSION SUMMER MEETING

In a collaborative effort, OSU Extension – Medina County and the North Central Regional Office have invited CCAO/CEAO to meet together on August 19-21, 2009 in Medina County (Wadsworth). Together with OSU Extension, Commissioners Pat Geissman, Stephen Hambley, and Sharon Ray and County Engineer Mike Salay will co-host this joint summer meeting at the Galaxy Restaurant & Banquet Center, in Medina County (Wadsworth). This is the first time that the three organizations will meet together. The theme of the meeting will be "Effective Government Through Collaboration."

NEW CCAOSC ENERGY PROGRAM – NATURAL GAS SAVINGS

Recently, the County Commissioners Association of Ohio Service Corporation (CCAOSC) announced a **new energy program** designed to help keep your natural gas costs under control. The CCAOSC has partnered with Palmer Energy to help manage a new natural gas program – CCAOSC Energy Solutions - for member counties. Program advantages: utilize strength of group buying and leverage buying power to shop the market and secure the best deals.

As you recall, the CCAOSC established a natural gas program in 2000 to save counties money through prepayment and aggregation. Since the inception of that program, the CCAOSC Natural Gas Program has saved the 30-member counties over \$7.4 million in gas commodities. In the past year, counties saved over \$1.3 million. Counties currently enrolled in the program should have returned the Participation Agreement for the new program by May 1. New counties and buildings may be added to the program at anytime, but signing up soon helps with the forecasting of energy consumption.

INSURANCE DEPARTMENT LAUNCHES ON-LINE TOOLKIT, REPRESENTATIVES AVAILABLE TO ANSWER QUESTIONS

The Ohio Department of Insurance has created an on-line toolkit to help Ohioans, including retirees, who have lost their health and life insurance benefits due to company lay-offs or cost-cutting measures determine other insurance coverage options.

OHIO MIGHT LOSE CONGRESSIONAL SEAT IN REAPPORTIONMENT

Preparations for the 2010 census have begun with the decennial head count just over a year away. Last December, the U.S. Census Bureau released new state-by-state population estimates for 2008 which shows what the 2010 census is likely to show. The Southern and Western states continue to grow, while the population growth rates in the Midwest and Northeast have slowed to a crawl.

The number of seats that each state gets in the U.S. House of Representatives, know as apportionment, is determined by entering state population totals into a formula established by federal law. Reapportionment

takes place after the Bureau release the 2010 census data by December 31, 2009. State redistricting begins after the Census Bureau delivers data to states no later than April 2011.

Looking at the 2008 state population estimates, Texas would be the big winner with three more seats; Arizona, Florida, Georgia, Nevada, and Utah would gain one seat; while Iowa, Louisiana, Massachusetts, Michigan, New Jersey, New York, Ohio, and Pennsylvania would lose one seat.

ATTORNEY GENERAL'S OPINIONS

SYLLABUS 2009-011

A person who has been convicted of felony domestic violence under the laws of Ohio and who has not been granted a full pardon by the Governor or had his conviction reversed or annulled or the record of his conviction sealed is barred by R.C. 2961.01 from holding the office of township trustee unless he has had the privilege of holding an office of honor, trust, or profit restored to him, as provided in R.C. 2967.16(C)(1) or its predecessors.

SYLLABUS 2009-012

A county auditor must have express or implied statutory authority to place on the tax list and duplicate any charge or penalty imposed and certified by a municipal corporation; a municipal ordinance purporting to bestow such authority on the county auditor is insufficient to empower the auditor to act.
