BWC REQUIRES TWO HOUR SAFETY TRAINING FOR GROUP RATING & GROUP RETRO COUNTIES

Beginning this year, the Ohio Bureau of Workers' Compensation (BWC) requires that Group Rating and Group Retro employers who have sustained an allowed claim in the past two years have a staff person attend two hours of safety training annually. The training can be offered by CCAO as the sponsoring organization, CompManagement, Inc. as CCAO's third party administrator, or the Ohio BWC. Both classroom training and web-based training will meet this training requirement.

2010 CCAO Group Rating Plan member counties are: Ashland, Auglaize, Brown, Carroll, Clinton, Crawford, Darke, Defiance, Fulton, Guernsey, Harrison, Henry, Highland, Huron, Knox, Marion, Morgan, Morrow, Noble, Paulding, Perry, Preble, Putnam, Sandusky, Washington, and Wayne.

2010 CCAO Group Retro Plan member counties are: Belmont, Champaign, Coshocton, Fairfield, Fayette, Gallia, Geauga, Hocking, Mercer, Monroe, Ottawa, Seneca, Union, Vinton, and Williams.

CompManagement will be contacting CCAO Group Rating and Group Retro members regarding on-line and classroom safety training programs which meet the training requirement and are offered for a fee.

CCAO will also offer safety training in 2010 which will meet the BWC training requirement. Information will be sent out as soon as these sessions are finalized.

As the group sponsor, CCAO is responsible for tracking and reporting each Group Rating and Group Retro member counties' compliance with this training requirement. CompManagement will be maintaining the required documentation on CCAO's behalf. RECOVERY ZONE BOND WAIVER DUE JANUARY 31

On Friday, December 18, 2009 CCAO, in cooperation with the Ohio Office of Budget and Management, the Ohio Department of Development (ODOD) and the Ohio Municipal League sponsored a Recovery Zone Bond Seminar and Briefing that was attended by nearly 80 persons. The state through ODOD has established a new Recovery Zone Bond Waiver Process and Reallocation System. Announced at the seminar, the new waiver process requires that all plans for issuing Recovery Zone Bonds must be submitted to ODOD by **January 31, 2010**. Counties that have not submitted plans to ODOD by this date will waive their allocation.

BROOKS ELECTED TO THE AGRIP BOARD OF DIRECTORS

Congratulations to David Brooks, CCAO's Managing Director of Property & Liability Insurance, for his election to serve on the Association of Governmental Risk Pools (AGRIP) Board of Directors! As a Board member, Brooks will be one of nine directors elected to a four-year term on the AGRIP's governing body.

Some purposes of AGRIP include: to promote risk pooling as a practical extension of a public entity's obligation to be a good steward of public funds, provide a forum for intergovernmental risk pools to exchange information on issues of mutual interest in the administration and operation of programs, and provide educational and professional support for governing bodies and employees of risk pools.

Brooks has been on the CCAO staff since 1995. He manages the daily operations of the County Risk Sharing Authority (CORSA), manages the CCAO Service Corporation Workers' Compensation Group Rating Plan, and is vice president of the CCAO Service Corporation.

MONTGOMERY COUNTY GENERAL FUND FIVE-YEAR FINANCIAL PLAN UPDATE

Two weeks ago, the County Information and Data Service (CIDS) (January 8, 2010) published an article about the Montgomery County Commissioners establishing the Montgomery County General Fund Financial Planning Committee to develop a new General Fund Five-Year Financial Plan for the period of 2010 – 2014 and to fulfill the County Commission's Strategic Initiative of Operational Efficiency. The Commissioners appointed 46 leaders in the business, health care, educational, nonprofit and government sectors.

In addition to the information in the previous article, the Committee also expressed the view that as a result of the changing economy, in some cases, over the last several years public employees, particularly at the lower

pay levels, have become more highly compensated than private sector counterparts when factoring in salary, medical benefits and pension contributions.

However, at the upper level managerial classifications, often the private sector significantly outranks the public sector employees. The Committee stated that “total compensation of the public and private sector should be more closely aligned where possible” and advised that particular consideration should be given to defined benefit pension plans still offered to all public employees in Ohio. The Committee noted that in 2007, only 21% of all private sector employees were still offered such retirement plans.

The Committee also found that many parts of the Ohio Revised Code are outdated, cumbersome and inefficient. According to the Committee, “The powers and responsibilities often do not reflect the emerging needs of county government. The ORC as it relates to county government needs to be restructured to affect positive change and efficiencies for county government and its citizenry.”

Finally, the Committee looked at the number of local governments and appointing authorities within Montgomery County. The Committee found that there are 26 separate political jurisdictions in the County where the same or similar services are being performed with the main difference primarily being jurisdictional boundaries. “Members of the Committee believe the level of resources required to support these similar services detracts from the County’s capability to offer a coherent economic development plan. The County’s elected officials and staff must help leverage opportunities for communities to come together by creating and building upon inter-city partnerships and, at the same time, identify opportunities to use its resources to accelerate consolidation and enhancement of services across the region.”

The Committee also noted that “as a “statutory” form of government, Montgomery County is, in many ways, hostage to the various and often archaic dictates of the Ohio Revised Code. It has little of the independence found in the “home rule” jurisdictions that make up the majority of the cities within the County’s borders. Noting that “Summit County currently operates as a charter county with a County Executive” and that recently “Cuyahoga County voters have overwhelmingly voted to move to charter county status” the Committee stated that: “Montgomery County needs to aggressively review whether a change from statutory government to a charter county would benefit the citizens of the county and the region by providing Montgomery County additional flexibility to meet the economic issues at hand; as well as maintaining Montgomery County’s competitive position as compared to Summit County, Cuyahoga County and other Ohio counties that may elect to move away from the restrictions embodied in their current form of government.”

REPORT SHOWS LATEST INITIAL UNEMPLOYMENT CLAIMS IN OHIO AMONG LARGEST NATIONALLY

Last week, the U.S. Department of Labor said that seasonally adjusted initial claims for unemployment benefits rose to 434,000 in the week ending Jan. 2, an increase of 1,000 from the previous week. At the same time, the most recent data available shows Ohio and some of its neighbors were among 12 states recording increases of more than 1,000 in initial claims as 2009 drew to a close. The largest increases for the week ending Dec. 26 were in Pennsylvania (+9,653), Kentucky (+6,069), Indiana (+5,537), Kansas (+5,166), and Ohio (+4,361). Michigan recorded an increase of 2,994. Among the dozen states with decreases in excess of 1,000, the largest was California (-23,160). Others included Texas (-7,956), Georgia (-4,661), Florida (-3,736), and North Carolina (-2,993).

ODNR ACCEPTING ENROLLMENT APPLICATIONS FOR FOREST LEGACY PROGRAM

According to the Ohio Department of Natural Resources (ODNR), woodland owners in 31 northeastern and southeastern Ohio counties can apply to participate in a federal conservation easement program that provides a one-time payment in exchange for voluntarily agreeing to permanently maintain their woods as working forests. Landowners who enter the Forest Legacy Program must agree to manage their woodlands according to plans developed in mutual cooperation with the Division of Forestry. If accepted into the program, landowners can receive a one-time payment for accepting a conservation easement on their property.

Two regions in Ohio, including six counties in northeast Ohio and 25 counties in eastern and southeast Ohio, have been identified as areas that would best benefit from the Forest Legacy Program. These counties have a relatively large amount of forest cover and a significant number of housing starts. These include: Adams, Ashtabula, Athens, Belmont, Carroll, Columbiana, Coshocton, Gallia, Geauga, Guernsey, Harrison, Hocking, Jackson, Jefferson, Lake, Lawrence, Meigs, Monroe, Morgan, Muskingum, Noble, Perry, Pike, Portage, Ross, Scioto, Summit, Trumbull, Tuscarawas, Vinton and Washington counties. Only forested properties within these counties are eligible for the program.

Ohio's forests have increased from just 10 percent of the state's landscape in the early 1900s to more than 30 percent today. While forest cover remains steady, the number of new forest landowners has increased from 320,000 to nearly 400,000 in the past decade. Application deadline: April 23, 2010. The U.S. Department of Agriculture Forest Service is administered in Ohio by the ODNR Division of Forestry. ATTORNEY GENERAL OPINIONS

SYLLABUS

2009-055

A county prosecuting attorney who notifies a board of county commissioners prior to the commencement of his term of office that he will engage in the private practice of law may not decide during his term of office not to engage in the private practice of law in order to receive, during the remainder of his term of office, the salary prescribed for a county prosecuting attorney who does not engage in the private practice of law.

SYLLABUS

2010-001

1. A board of county commissioners has a mandatory duty under R.C. 307.01 to provide the county law library resources board with offices and necessary facilities.
2. A board of county commissioners has no statutory authority to charge a county law library resources board for space or utilities, or a fee for indirect costs, overhead, or centralized or support services.
3. A board of county commissioners has the discretion, but is not required, to appropriate money from the general fund for the use of the county law library resources board beyond the offices and necessary facilities the board of commissioners is required to provide under R.C. 307.01.
