#### 2010 CCAO NOMINATING COMMITTEE APPOINTED

The CCAO Executive Committee has approved the appointment of a five member Nominating Committee at recent meeting of the Executive Committee. The Nominating Committee, appointed by CCAO President Paula Brooks (Franklin), will be chaired by Past President Kerry Metzger, Tuscarawas County Commissioner. Other members include: Peter Ferguson (Stark), Ed Humphrey (Clermont), Pete Gerken (Lucas), and Kim Edwards (Ashland).

It is the responsibility of the committee to recommend a slate of officers and board members to be elected at the CCAO Luncheon and Annual Business Meeting to be held on Monday, December 6, 2010, at the held during the CCAO/CEAO Winter Conference to be held at the Hyatt Regency in Columbus. Nominations will also be accepted from the floor. The committee will be nominating candidates for the offices of president, first vice president, second vice president, secretary, and treasurer.

In addition, seven members will be nominated to serve on the Board of Trustees for two-year terms. The Nominating Committee will also fill any vacancies that may exist where members elected to a two-year term will not be returning to office or where a member forfeits office for non-attendance. The seven members whose terms to the Board expire this year include: Tim Brown (Wood), Kim Edwards (Ashland), Greg Green (Hocking), Margery Paeltz (Brown), David Pepper (Hamilton), Roger Tackett (Clark), and Ron Widener (Miami).

The nine members appointed by President Brooks whose one-year term to the Board expires at the end of this year include: Steve Arndt (Ottawa), Sam Bassitt (Allen), Mike Crabtree (Scioto), Pete Gerken (Lucas), Peter Lawson Jones (Cuyahoga), Ted Kalo (Lorain), Ula Jean Metzler (Pickaway), Bob Peterson (Fayette), and Tommy Thompson (Delaware).

In accordance with the CCAO Bylaws, the six most recent past presidents who still hold the office of county commissioner are entitled to a seat on the Board of Trustees. In 2011 those individuals will include: Paula Brooks (Franklin), Bob Corbett (Champaign), Lenny Eliason (Athens), Olen Jackson (Morrow), Kerry Metzger (Tuscarawas), and Daniel Troy (Lake).

The committee must make its recommendations no later than November 3. The report will then be published in the CIDS and an individual copy of the report will be sent to each commissioner.

#### LUCAS COUNTY COMMISSIONERS APPROVE ESTABLISHMENT OF LAND BANK

Last week, Lucas County Commissioners Pete Gerken, Ben Konop and Tina Skeldon Wozniak voted unanimously to establish the Lucas County Land Reutilization Corp. The non-profit land bank, the second one established in Ohio, focuses on putting the county's abandoned and foreclosed property to good use. The new entity has the power to acquire, market, and maintain properties that are vacant within 90 days rather than disposed of them through the sheriff's auction, which can take nearly two years. Parcels will begin to be acquired for marketing and resale within weeks.

The corporation will be run by five to nine members, to include, by statue, two county commissioners, the county treasurer as chair, the mayor of Toledo, and appointee from Sylvania Township, and someone with real estate or development experience. A full-time staff of one or two will support the corporation.

According to Wade Kapszukiewicz, Lucas County Treasurer, the corporation's revenue will come from an increase in the interest rate charged on delinquent taxes. Last year, the county treasurer foreclosed on 324 properties for nonpayment of taxes. About \$1.5 million annually is expected to come from that source along with grants and revenue from the sales of property. The land bank can also accept other abandoned properties as a result of mortgage default and any of the 900 belonging to the city of Toledo under a "passive" land bank that was set up in the 1980's.

Cuyahoga County was the first active land bank in Ohio. The Lucas County program was modeled on a successful effort in Genesee County (Flint), Michigan. Establishment of land banks was authorized for

counties over 60,000 population by Sub. H.B. 313, which was passed by the General Assembly and signed into law by Governor Strickland this year.

#### CUYAHOGA COUNTY HOLDS PRIMARY FOR COUNTY EXECUTIVE & COUNTY COUNCIL

The Cuyahoga County Board of Elections released the results of the first-ever primary for county executive and county council that was held on Tuesday, September 7. Voters overwhelmingly chose candidates with political experience over political newcomers who lagged behind in most of the seats. Candidates will face off in the general election on November 2 to elect a county executive and 11-member county council for a reorganized charter government approved by voters last fall. #### STATE ACTIVITIES

#### OHIO COMMISSION ON LOCAL GOVERNMENT REFORM AND COLLABORATION

The Ohio Commission on Local Government Reform and Collaboration was responsible for developing recommendations on ways to increase the efficiency and effectiveness of local government operations, to achieve cost savings for taxpayers and to facilitate economic development in the state. The Commission was co-chaired by Lucas County Auditor Anita Lopez and Lake County Commissioner Daniel Troy. In addition, Montgomery County Commissioner Dan Foley served on the Commission.

Through 18 months of public testimony, written reports and university lead research, the Commission has studied a wide range of information. The final report of the Commission has been submitted to the Governor and the General Assembly. The report is now available on line at www.ohioreformandcollaboration.org.

#### **FEDERAL ACTIVITIES**

#### GREAT LAKES RESTORATION INITIATIVE GRANTS ANNOUNCED

On Tuesday, September 7,U.S. Environmental Protection Agency Administrator Lisa P. Jackson announced EPA's first Great Lakes Restoration Initiative competitive grants in Toledo. The first of the Ohio Great Lakes Restoration Grants totaling \$1,968,228 are:

- \$1 million to Ohio Environmental Protection Agency for Cuyahoga County surface water improvement to enhance nonpoint source pollution management; stream and wetland restoration; and, innovative stormwater management and green infrastructure demonstrations in Lake Erie tributaries.
- \$250,000 to the Ohio Office of Budget and Management for Toledo Harbor sediment project to create significantly enhanced native fish, bird and plant habitats in Western Lake Erie through the beneficial reuse of dredged sediment.
- \$550,228 to the University of Toledo for prevention of surface water contamination from biosolids to evaluate the feasibility of a tile drain cap as a way to mitigate contamination of waterways after biosolid application.
- \$168,000 to Ohio Department of Natural Resources for Maumee Bay and Thurston State Parks for reforestation due to damage from the Emerald Ash Borer. Replacement trees will restore the shade, prevent soil erosion, restore carbon sequestration capacity, and maintain riparian forest habitat.
