### ADULT PROTECTIVE SERVICES FUNDING APPLICATIONS AVAILABLE

The Ohio Department of Job and Family Services (ODJFS) has information on both planning funds and innovation funds available to county departments of job and family services for purposes of adult protective services (APS). (Click <a href="here">here</a> to view the full packet.) Note – the deadline to apply for program innovation funds, the largest available award, is February 16<sup>th</sup>.

The two types of funds are the result of a recommendation made by an APS workgroup created in HB 483 charged to both recommend the expenditure of \$10 million for APS appropriated in HB 483, as well as to identify long-term program improvements.

In addition to information around the funds and their respective application processes, the packet contains the workgroup report as well as proposed statutory language that is designed to create a core minimum service level in every county in order to ensure an appropriate response to cases of elder abuse. ## NACO TESTIFIES BEFORE RARE JOINT SENATE & HOUSE HEARING ON "WATERS OF THE U.S." PROPOSED RULE & THE IMPACTS ON STATE & LOCAL GOVERNMENTS

On February 4, the National Association of Counties (NACo) testified before the Senate Environment and Public Works Committee (EPW) and the House Committee on Transportation and Infrastructure (T&I) at a hearing, "Impacts of the Proposed Waters of the United States Rule on State and Local Governments." NACo testimony focused on the importance of the local, state and federal partnership in crafting practical rules to ensure clean water without impeding counties' fundamental infrastructure and public safety functions.

At the hearing, NACo discussed the main reasons that contributed to their call for withdrawal of the rule, including the proposal's impacts on counties; an inadequate consultation process with state and local governments; ambiguous and inconsistent terminology; and ongoing delays with the current permitting process.

The U.S. Environmental Protection Agency (EPA) indicated the proposed rule was in response to stakeholder requests for a rulemaking and will make it easier to determine what waters fall under federal jurisdiction. The U.S. Army Corps of Engineers stressed the rule was based on science and would give regulators in the regional offices greater clarity on jurisdictional waters.

In April 2014, The U.S. Environmental Protection Agency (EPA) and the U.S. Army Corps of Engineers (Corps) jointly released a new proposed rule that would amend the definition of "waters of the U.S." within the Clean Water Act and dramatically expand the range of public safety infrastructure that falls under federal permitting authority. The public comment period for "waters of the U.S." closed on November 14, 2014. The agencies are currently reviewing over one million comments and plan to release a final rule by late spring of 2015. Since the proposal was unveiled in April, NACo has advocated for greater clarity and launched an online resource hub and action center.

### PRESIDENT'S BUDGET: PROPOSALS IMPACTING COUNTIES

On Monday, President Obama released his <u>Fiscal Year 2016 Budget</u>, a \$4 trillion proposed budget that includes spending increases on infrastructure, education, tax incentives for low-to-moderate-income people, and other incentives. The 2015 federal fiscal year starts on October 1. Here are some highlights:

Community Development Block Grant Program (CDBG) – The President calls for \$200 million less for the CDBG Program, after national associations have been fighting to keep the program funded at \$3 billion a year. CDBG grants go to roughly 1,200 units of state and municipal government across the country to pay for a wide range of local needs, such as water infrastructure, affordable housing and meal programs for seniors. While the grant program saw a brief funding surge when Obama first took office, the long-term trend has been less money over time. Total federal disbursements already declined by about 30 percent between 2004 and 2014.

<u>Tax-Exempt Municipal Bonds</u> - The Budget would limit the value of most tax deductions and exclusions to 28 cents on the dollar on higher-income earners, which would likely raise rates for governments. Currently, interest earned on municipal bonds is not taxed - a benefit to bondholders that allows governments to finance their bonds at a lower interest rate and save money. Governmental associations estimate that total borrowing costs for cities, counties and states could increase by more than 50 percent if municipal bonds' tax-exempt status was repealed entirely.

<u>Earned Income Tax Credit</u> – The President proposed to extend eligibility to the federal Earned Income Tax Credit (EITC) to adult workers with no dependent children, a segment of the working poor mostly excluded by the current program.

<u>Early Childhood Initiatives</u> – The President called for tens of billions to fund a universal pre-kindergarten program along with \$750 million in preschool development grants for states.

<u>Workforce Development</u> – The Budget includes a \$6 billion, four-year program of grants to partner with community colleges to create apprenticeships for students in new fields.

<u>Competitive Grants for Energy Efficient Infrastructure</u> – The Energy Department would provide \$200 million in a one-time performance grant to support state governments to cut energy waste and modernize power grids.

<u>Transportation</u> – The budget would almost double public transit investments and provide funding for buses, subways, light rail, and commuter trains. Also included was \$302 billion to "repair and modernize" highways and bridges. This would be funded by eliminating deductions and exemptions in the corporate tax code.

### **OHIO ATTORNEY GENERAL OPINIONS**

### **SYLLABUS - 2015-003**

Pursuant to R.C. 5126.0221(B)(3), a classified employee of a county board of developmental disabilities who was employed on or after October 31, 1980, is subject to dismissal from employment when that employee's immediate family member is elected as a county commissioner of a county that is served by the county board of developmental disabilities that employs the classified employee.

### **SYLLABUS - 2015-004**

- 1. A board of county commissioners and a municipal corporation may establish a regional council of governments (1) to operate a public safety answering point under R.C. Chapter 128 and, (2) if the regional council of governments is authorized to act on behalf of the board of county commissioners pursuant to R.C. 167.03(C) or R.C. 167.08, to operate a countywide public safety communications system pursuant to R.C. 307.63.
- 2. A regional council of governments that operates a public safety answering point under R.C. Chapter 128 may not receive funding through contracts for dispatch services provided to other political subdivisions when the dispatch services are provided in association with the public safety answering point. A regional council of governments may, however, receive funding for the costs of establishing, equipping, furnishing, operating, or maintaining a public safety answering point operated by the regional council of governments as set forth in the formula in the county's final 9-1-1 plan adopted pursuant to R.C. 128.03 and R.C. 128.07.
- 3. A regional council of governments has no authority pursuant to R.C. Chapter 128 to receive funding through contracts for dispatch services provided to other political subdivisions when the dispatch services are not provided in association with a public safety answering point.
- 4. A regional council of governments has no authority pursuant to R.C. 307.63 to receive funding through contracts for dispatch services provided to other
