The [Area 7 Workforce Investment Board](#) in cooperation with CCAO, the Ohio Job and Family Service Directors Association, and other workforce investment boards will present a “Workforce Investment Opportunity Act (WIOA) Implementation Symposium” on March 26, 2015 at the Columbus Airport Marriott Hotel, 1375 N Cassady Avenue, in Columbus. The Symposium will provide local elected officials and decision-makers with information to effectively implement the WIOA. Attendees will hear from state and national leaders on the key provisions and requirements of the new workforce legislation.

The keynote speaker is John Colbert, who was a senior official in the Clinton Administration as chief of staff with the U.S. Department of Labor's Employment and Training Administration overseeing an \$11 billion budget. AFFORDABLE CARE ACT – “CADILLAC TAX” WEBINAR – APRIL 8

CCAO is pleased to offer a one-hour “Affordable Care Act—Cadillac Tax” webinar on April 8 at 9:30 a.m. The

"Cadillac Tax" is an excise tax scheduled to take effect in 2018 to reduce health care usage and costs by encouraging employers to offer plans that are more cost-effective and engage employees in sharing in the cost of care. It is a 40% tax on employers that provide high-cost health benefits to their employees. This is a permanent annual tax beginning in 2018 with the purpose of generating \$80 billion over the next 10 years to help finance the expansion of health coverage. Our speaker, Marc Fishel - a partner in the law firm of Fishel Hass Kim Albrecht - will discuss the following topics:

- What is the Cadillac (Excise) tax?
- What are the excise tax issues?
- Other issues: Reporting requirements and King v. Burwell pending before the United States Supreme Court

WORKFORCE AREA DESIGNATION PROCESS INFO AVAILABLE – REQUESTS DUE BY MAY 29

This week, county commissioners, executives and councilmembers received a memo from the Ohio Department of Job and Family Services on the [designation of workforce development areas under the Workforce Innovation and Opportunity Act](#) (WIOA). Local workforce development areas are designated for the

purpose of implementing WIOA, establishing an OhioMeansJobs service delivery system, and administering the workforce development programs. Under the federal legislation, the governor, in consultation with the local chief elected official, is required to designate local workforce areas. The definition of chief elected official is the chief elected executive officer of a unit of general local government in the area (i.e., county commissioner, mayor, county executive, county council member or a combination of all). To implement WIOA, the chief elected official has the responsibility to request local workforce development area designation. **Requests for designation are due by Friday, May 29, 2015.**

APS PROGRAM INNOVATION & APS CAPACITY BUILDING GRANTS UPDATE

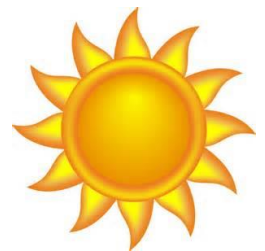
Per HB 483, the Adult Protective Services (APS) Funding Workgroup was developed to make a formal [recommendation](#) regarding the usage of one time \$10 million. The workgroup recommended utilizing the one-time funding to support and build upon the current Adult Protective Services framework at both the state and county levels. Of the one-time allotment, \$7,368,800 will be used for the APS Planning Process and APS Innovation Fund, which includes both the APS Program Innovation Grants and APS Capacity Grants. The remaining \$2,631,200 will be utilized for statewide APS core training, the development of a statewide APS hotline, and implementation of a statewide APS data collection and reporting system.

Please note: all **Capacity Grant Proposals are due by 5:00 p.m. on April 1, 2015.**

AOS ANNOUNCES "SUNSHINE AUDIT" INITIATIVE

This week, State Auditor Dave Yost announced a new program to help resolve public records complaints before they go to court. The new "sunshine audit" initiative is also meant to give citizens who cannot afford to engage in expensive legal battles a means to resolve unfulfilled requests for public documents. Auditor Yost said the process, which his office is able to do under its existing statutory authority with current resources, would require any individual who thinks he or she has been wrongfully denied access to a public record to file a complaint with his office.



If the records being sought lie with a local government, the Ohio Attorney General's (OAG) office already has a mediation program to help resolve disputes. If one party refuses to participate or the mediation does not come to a satisfactory outcome, individuals may then bring the issue before the auditor's Open Government Counsel. Any complaint related to a record held by the state would automatically go to the auditor's office because the OAG is considered to have a conflict of interest.

If the auditor's office finds the government is noncompliant, the entity would hopefully "take that finding to heart" and provide the record. Regardless of the outcome, the "disappointed party" still has the authority to take the case to court. The auditor noted there might be cases where the office is unable to make a determination and would issue a letter stating that. The auditor's office has no means to penalize a government entity that refuses to provide a record even if the office determines it should. The findings are not binding, but Yost said they are given a "presumption of validity" and could be used as evidence in court. Many times,

records requests are denied for being "overly broad." Yost said those are the type most often litigated and he hopes his office will develop guidelines on what that term means. [Read more...](#)

2015 TECHNICAL ASSISTANCE GRANTS FOR PIPELINE SAFETY

The U.S. Department of Transportation, Pipeline and Hazardous Materials Safety Administration (PHMSA) is now accepting applications for the 2015 Technical Assistance Grants for communities seeking engineering or other scientific analysis of issues relating to pipeline infrastructure. Governmental entities or nonprofit groups may qualify for a grant of up to \$100,000 per year. Applicants must be local communities or groups of individuals related to the safety of local pipeline facilities. "Communities" are defined as cities, towns, villages, counties, parishes, townships, boroughs and similar governmental subdivisions or consortia of such subdivisions. APRIL IS NATIONAL COUNTY GOVERNMENT MONTH: RAISE AWARENESS ABOUT COUNTIES



CCAO and NACo encourage counties across the country and hold activities and events in April as part of National County Government Month (NCGM). Activities such as open houses at county facilities, conducting programs with schools, recognizing veterans and employees, and issuing proclamations help county leaders raise public awareness and understanding about the roles and responsibilities of county government. Since 1991, CCAO and NACo have encouraged counties to actively promote county government programs and services.

The 2015 national theme is "Counties Moving America Forward: The Keys are Transportation and Infrastructure," which is the focus of NACo President Riki Hokama's presidential initiative. Following the theme, counties will be showing their residents how they are at the forefront of strengthening transportation and the infrastructure fundamental to moving America forward. Counties play a key role in everything from moving people and goods to moving the economy forward.

Meet with your member of the Ohio Congressional Delegation: One activity that all counties should pursue during NCGM is to meet with their members of Congress. During those meetings, county officials should stress that federal policies matter to county government and county government matters to America's local communities. They should know that county governments are responsible for the fundamental building blocks for healthy, safe and vibrant communities and that federal policy decisions have a major, cascading impact on county government.
