The formula changes will reduce 2015 valuation for taxes to be paid in 2016 to better reflect crop yields and prices, resulting in a 4.3 percent decrease in taxes per acre. AFFORDABLE CARE ACT – “CADILLAC TAX” WEBINAR – APRIL 8

CCAO is pleased to offer a one-hour “Affordable Care Act—Cadillac Tax” webinar on April 8 at 9:30 a.m. The “Cadillac Tax” is an excise tax scheduled to take effect in 2018 to reduce health care usage and costs by encouraging employers to offer plans that are more cost-effective and engage employees in sharing in the cost of care. It is a 40% tax on employers that provide high-cost health benefits to their employees. This is a permanent annual tax beginning in 2018 with the purpose of generating \$80 billion over the next 10 years to help finance the expansion of health coverage. Our speaker, Marc Fishel - a partner in the law firm of Fishel Hass Kim Albrecht - will discuss the following topics:

- What is the Cadillac (Excise) tax?
- What are the excise tax issues?

Colbert helped direct the nation’s major job training and youth development programs. The keynote speaker was sponsored by Maximus. COUNTY WELLNESS

DELAWARE COUNTY TACKLES STAIRWELL ENHANCEMENT PROJECT, AS PART OF THEIR WELLNESS INITIATIVE

In an effort to increase and promote physical activity through stair use, the Delaware County Wellness Program partnered with the Delaware General Health District to enhance the stairwells of the Rutherford B. Hayes Services Building, a county owned building. The project was finalized in late 2014 and included visual enhancements as well as targeted health messages at all high traffic areas in the building. Enhancements included new paint, motivational posters, elevator signage, and added shelving to display local art work.



The \$3,600 project was partially funded by the County Employee Benefits Consortium of Ohio (CEBCO) through the wellness grant provided to the county. This grant is provided to every county on the CEBCO health plan, annually. The other portion of funds for this project was provided by the Delaware General Health District with public health dollars specifically allocated for chronic disease prevention, physical activity, and nutrition.

This project is considered an environmental change; an evidence-based method designed to drive behavior change and it is one of the many recommendations provided to counties on CEBCO's health plan by Tori Sinclair, CEBCO's Wellness Coordinator. This is one of many simple changes a county can institute to address the health of their employee population.

Project co-coordinators, Cindi Blair with the county's insurance and risk department, and Kelsey Kuhlman with the General Health District, initiated a pre and post survey as part of this project. Usage data was collected prior to the project for a seven day period and data was collected after the project for the same week days. An increase of 20 percent usage was documented. "Choosing the stairs over the elevator is a quick and easy way to promote frequent movement among all employees and visitors to the Hayes Building," says Cindi Blair.

STATE ACTIVITIES

BALLOT BOARD SETS PROPOSED MARIJUANA AMENDMENT AS SINGLE ISSUE

ResponsibleOhio can begin collecting signatures to place its marijuana legalization amendment on the November ballot following the Ballot Board's March 27th approval of the proposal as a single issue. Petitioners have until July 1 to collect 305,591 valid signatures in order to place the issue before voters.

The proposal, which would legalize marijuana use for Ohioans ages 21 and older, includes provisions setting a tax structure and regulations and creates a commission to oversee the growing, testing and market phases. It also lists the addresses of 10 growing locations - a portion of the amendment that has drawn opposition from state leaders and other marijuana legalization groups. Last-minute language was added before a second petition filing to allow individuals age 21 and older to grow up to four marijuana plants in their homes, as long as they procure a license.

AVIAN INFLUENZA UPDATE

Poultry farms across the United States are carefully monitoring recent findings of avian influenza (AI) in western and central regions of the country. AI has been detected in backyard flocks and commercial turkey flocks, and the disease has the potential to impact farms of all sizes across the state. The strains of AI have been identified as highly pathogenic and have resulted in the loss of many birds to date.

According to U.S. Department of Agriculture (USDA), the identified strains of AI do not pose any threat to public health, nor are they a risk in properly cooked eggs, chicken and turkey. Disease prevention on poultry farms is a top priority, and the Ohio Poultry Association and Ohio's egg, chicken and turkey farmers are implementing robust disease prevention processes to protect poultry flocks. Migratory birds and waterfowl are believed to be a primary source of transmission of AI into commercial flocks.

To date, there has been no incidence of AI in commercial egg, turkey or broiler chicken farms in Ohio, or on any Ohio farms. [Read more...](#)

HOUSE AND SENATE RELEASE FEDERAL BUDGET PLANS

Last week, both the House and Senate Budget Committees released their respective budget plans as the federal budgeting process shifted into high gear. On March 17, House Budget Committee released the House budget resolution, and on March 18, Senate Budget Committee released the Senate's version. The two plans have significant differences, and the budget committees in each chamber have marked the bills and leaders are working to gain support before the measures go to the chambers' floors for votes.

This process, in which Congress begins to lay out its unified budget resolution, follows the release of the president's FY 2016 budget last month. While the president's budget outlines the Administration's policy priorities, Congress ultimately holds the "power of the purse," or the final say over how programs are funded through the twelve annual appropriations bills that will fund the government beginning October 1, 2015.

Unlike the president's budget, which is detailed, the congressional budget resolution essentially consists of a set of numbers that state how much Congress will spend across broad categories and how much revenue the government will collect. The spending totals in the budget resolution are stated in two different ways: the total amount of budget authority, or limits on new financial obligations federal agencies may incur, and the outlays, or estimated level of expenditures or cash flow that will help determine the size of the overall deficit or surplus.

Congress is supposed to pass a concurrent budget resolution by April 15, but this process often takes longer, and in recent years has not happened at all. However, the stakes are higher this year because the new Republican-controlled Congress has the option to use an important legislative maneuver known as budget reconciliation. [Read more...](#)

SUPREME COURT WEIGHS IN ON MARKETPLACE FAIRNESS ACT

On March 10, the [Marketplace Fairness Act \(MFA\) of 2015 \(S. 698\)](#) was introduced in the U.S. Senate and has been referred to the [Finance Committee](#). Similar to the legislation that passed the Senate in 2013 with strong bipartisan support, the bill would not create a new tax; it would simply allow states and local governments to enforce existing sales tax laws. By allowing the enforcement of existing sales taxes, the MFA would allow Main Street retailers to compete on a level playing field against out-of-state Internet retailers.

The current inability of states and local governments to enforce existing sales taxes is essentially the result of decades-old Supreme Court decisions – [National Bellas Hess v. Department of Revenue \(1967\)](#) and [Quill Corp. v. North Dakota \(1992\)](#). Both cases dealt with the issue of the physical presence necessary for a state to impose a duty to collect upon a seller that was not located within a state. Even though the Quill decision, which states that a business must have a physical presence in a state before the state can require it to collect sales taxes, upheld Bellas Hess, the Court also held that Congress ultimately has the authority to regulate interstate commerce and could overrule the decision through legislation.

An interesting development arose recently in the Supreme Court when the Justices issued a decision in the case [Direct Marketing Association v. Brohl](#). The case involved a Colorado law requiring remote sellers to inform Colorado customers annually of their purchases and to send the same information to the Colorado Department of Revenue. The Court ultimately decided to send the case back down to the lower court for further action. In summary, Justice Kennedy wrote that in the more than two decades since Quill, significant advances in technology and an increase in consumer sophistication have created a situation in which the Quill decision harms states to an extent greater than was contemplated before. NACo TESTIFIES AT THE "WATERS OF THE US" HEARING



Last week, the National Association of Counties (NACo) testified at a hearing titled, "To review the definition of 'waters of the United States' proposed rule and its impact on rural America." The [testimony](#), which was presented before the U.S. House Committee on Agriculture's Subcommittee on Conservation and Forestry, focused on the proposed rule's potential harmful impacts on rural America. Subcommittee Chairman Glenn Thompson (R-Pa.) stressed that the proposed rule, as drafted, would have significant negative consequences for rural America. The hearing addressed the legal complications that agricultural and rural communities could face, the costs to states and counties to implement the proposed rule and the obstacles to building rural infrastructure under the rule. USDA IMPLEMENTS 2014 FARM BILL PROVISION TO LIMIT PAYMENTS TO NON-FARMERS

This week, the U.S. Department of Agriculture (USDA) announced a proposed rule to limit farm payments to non-farmers, consistent with requirements Congress mandated in the 2014 Farm Bill. The proposed rule limits farm payments to individuals who may be designated as farm managers but are not actively engaged in farm management. In the Farm Bill, Congress gave USDA the authority to address this loophole for joint ventures and general partnerships, while exempting family farm operations from being impacted by the new rule USDA ultimately implements.



The current definition of "actively engaged" for managers, established in 1987, is broad, allowing individuals with little to no contributions to critical farm management decisions to receive safety-net payments if they are classified as farm managers, and for some operations there were an unlimited number of managers that could receive payments.

The proposed rule seeks to close this loophole within the guidelines required by the 2014 Farm Bill. Under the proposed rule, non-family joint ventures and general partnerships must document that their managers are making significant contributions to the farming operation, defined as 500 hours of substantial management work per year, or 25 percent of the critical management time necessary for the success of the farming operation. As mandated by Congress, family farms will not be impacted.
