***UNEXPIRED TERMS**

HAMILTON - **Dennis Deters** – R – was appointed to and ran for the unexpired term of Greg Hartman, who resigned.

HARDIN – **Gerald Potter** – R – was appointed to the unexpired term of Ed Elliot who died. Potter did not run.

MUSKINGUM – **Cindy Cameron** – R – was appointed to the unexpired term of Todd Sands who resigned due to medical reasons.

SCIOTO – **Cathy Coleman** – R – was appointed to and ran for the unexpired term of her late husband, Doug Coleman.

STARK – **David Bridenstine** – D – was appointed to the unexpired term of Commissioner Thomas Bernabei, who was elected Mayor of Canton. Bridenstine did not run.

SUMMIT – **Ilene Shapiro** – D - Summit County Council member (at large) and Council President – was appointed to and ran for the unexpired term of County Executive Russ Pry who died.

Clair Dickinson – D - was appointed to and ran for Shapiro’s at large Council seat.

Elizabeth Walters – D – was appointed to and ran for the unexpired term of Council Member Sandra Kurt who was appointed to and ran for the unexpired term of Clerk of Courts Daniel Horrigan, who was elected Mayor of Akron.

Jeff Wilhite – D – was appointed to and ran for the unexpired term of Council Member Frank Comunale, who resigned his seat to work with the Summit County Department of Job and Family Services in senior citizen outreach.

WAYNE – **Sue Smail** – R – was appointed to the unexpired term of Commissioner Jim Carmichael who died. Smail ran for the open of Scott Wiggam who was elected to the Ohio House of Representatives.
