Gov. DeWine's Press Conference: eight counties move to Red Level 3


During his press conference today, Gov. DeWine announced that eight counties are newly Red Level 3 this week under the Ohio Public Health Advisory System: Allen, Athens, Delaware, Licking, Lucas, Richland, Scioto, Union. Trumbull County has moved from Red Level 3 to Orange Level 2. Athens County has a "star" meaning it is on "the watch list" for becoming Purple Level 4. Hamilton, Butler, Cuyahoga counties are no longer on "the watch list."

The newly Red Level 3 counties will be under a mandatory face covering order effective tomorrow, Friday, July 17th at 6 p.m. At that time, approximately 60 percent of the Ohio population will be living under a mandatory face covering order. Order text can be found here.









Gov. DeWine invited Dr. Andrew Thomas, Chief Clinical Officer, The Ohio State University Wexner Medical Center to <u>explain</u> the indicators as well as what each level signals to the public.

There was an increase of 1,290 in total COVID-19 cases statewide yesterday. For more COVID-19 numbers, visit <u>coronavirus.ohio.gov</u>.

Lt. Gov. Husted made a couple of announcements related to PPE in Ohio. He announced \$20 million in grant funding through the Ohio Development Services Agency to help Ohio manufacturers produce PPE. Additionally, JobsOhio and its regional partners will distribute PPE toolkits for a total of 1.5 million 3-ply masks, 150,000 KN95 masks, and 15,000 bottles of hand sanitizer to small businesses. To date, more than 50 million pieces of this PPE have been distributed across the state.

OBM releases June 2020 Monthly Financial Report

Late last week, the Ohio Office of Budget and Management released its monthly financial report for June 2020. This report was the final monthly report for state fiscal year 2020.

Overall, the impact of the COVID-19 pandemic continues to be felt across many sectors of the Ohio economy and is apparent across multiple revenue streams. FY 2020 revenues ended the year 4.6 percent below estimates, or approximately \$1.1 billion. For the month of June, sales tax performance improved compared to previous months. Non-auto sales tax came in 4.2 percent under estimate while auto sales tax exceeded estimates by 24.1 percent. The strength of revenue streams going forward remains very uncertain, however. Several sources of fiscal stimulus are scheduled to soon end and changes in consumer activity could lead to significant fiscal headwinds going forward in FY 2021.

Updated County Advisory Bulletin: Layoffs and Furloughs under Civil Service Law

Following the recent enactment of HB 481, CCAO has worked with Marc Fishel to provide an update to County Advisory Bulletin 2020-12: Layoff and Furloughs Under Civil Service Law. The update reflects the additional furlough capability counties and other local governments received under HB 481 as well as additional information on the interplay between furloughs, modified work weeks and FFCRA leave.

Ohio Jobless Claims for Sunday, July 5, through Saturday, July 11, 2020

Ohioans filed 35,422 initial jobless claims last week, according to Ohio Department of Job and Family Services (ODJFS) statistics reported to the U.S. Dept. of Labor today. This is 238,793 fewer than the peak earlier this year. Ohioans filed 429,638 continued jobless claims last week, which were 346,664 fewer than the peak earlier this year. The total number of initial jobless claims filed in Ohio over the last 17 weeks (1,499,712) is more than the combined total of those filed during the last three years. To read more, click here.
